4. Joint Committee Reports to be given at Joint Board meeting.

5. 2018 Conference Update

- 150 speakers and attendees are registered for the conference.
- 45 preconference attendees are registered.

- Past board meeting discussions regarding discounts for speaker registration.
 - Reimbursement for travel expenses related to recruited speakers was discussed.
 - The number of tracks and preconference topics were discussed.
 - Invasive species was a topic at the recent storm water conference in Bozeman, which represents overlap with 2018 pre-conference.
6. By-Laws Revisions project
- AWWA has changed the format of the by-laws and recommends use by each Section.
 - Jeff is committed to completing the revised by-laws in the recommended format during his tenure as Past Chair.
 - Robin noted that revisions and clarifications should be considered for the Policy and Procedures Manual, especially dealing with the Joint Annual Conference with the Montana Water Environmental Association. The question was raised about having a written agreement in place to formalize the arrangement and identify specific details with the rotational pre-conference, revenue sharing/proceeds, etc. The board agreed that it should be addressed.
7. Nominations for Junior Trustee
- Kurt Vause recently transitioned to Montana Section and would be a good candidate for the Board.
 - Ross Mollenhauer and Louis Engels were also mentioned as potential nominees.
 - David Carlson was mentioned and is also interested in filling the Secretary/Treasurer position.
8. Montana Records Management
- The storage company has been purchased, and the cost has increased substantially from last year.
 - Wayne recommended asking AWWA for guidance on records.
 - Need to look through the information and discard what is no longer needed to reduce the rental fee.
9. Water Meter Webinar Proposal
- Robin has been approached by a vendor to sponsor a webinar.
 - General opposition was expressed given the potential to alienate other vendors.
 - Encourage vendors to submit abstracts for consideration by the Program Committee to avoid events that may be a sales pitch.
10. Cybersecurity training content available
- AWWA has prepared workshop content that is available for Section use.
 - 4-hour training event with materials and trainer guide.
11. 2018 EPA Training Agreement update
- The session is scheduled for August 15, 2018 in Lewistown.
 - Postcards will be sent out to operators regarding 2018 EPA Training and the One AWWA Operator Scholarships in cooperation of METC.
 - Reimbursement adjusted to \$4,200.
 - Past attendance has met or exceeded expectations.

12. Other Business

- 2018 AWWA Fly In report: discussed under the Legislative Committee report.
- 2018 YP Summit San Antonio Report: Keeley B. will provide at joint meeting.
- ACE18 Las Vegas: June 11-14: John +3 from Bozeman, Greg, Jeff A, Karen Sanchez, Dave Carlson and Nate are attending.
- Taste Test Competition: need to have a member of the board deliver water if the system is unable to attend ACE 2018.
- Summer Workshop Denver: July 25-26 – Jeff J attending.
- 2018 RMSO Sitka: August 15-17 – Nate and John attending.
- Water Equation: Robin has information available. The intent is to encourage the next generation to consider careers in the water industry to address the pending retirement of a significant portion of the current workforce. Two \$500 scholarships are available for training. Membership in AWWA is not required.
- Puerto Rico: Appreciation for the \$1000 gift was received.
